"I would like to formally request that the Parish Council considers the position of residents in the vicinity of Tinkers Lane, who are reliant on the use of septic tanks or cesspits for the disposal of waste water and sewage.

As you know we have a high water table in Hadlow Down, and the unprecedented rainfall this year has increased the need to empty cesspits more frequently, and at ever increasing costs.
